

How to Apply for F-1 Student Visa

Participants in the part time study (less than 18 clock hours per week) courses usually come on a B-2 tourist visa or under the visa waiver program.

Students coming for full-time study (18 or more hours per week) in the Intensive English, Intensive English for University Preparation, or Intensive Academic Preparation courses come on an F-1 student visa.

If you already have a F-1 visa from other school, you don't need to apply for another F-1 visa, but please bring your valid passport, I-20, and F-1 visa.
